Dear Child Placement Review Board members,

The New Jersey State Child Placement Advisory Council (CPAC) By-Laws call for a June Election. The CPAC Nominating Committee is presently recruiting candidates for the 2018 slate. Any Child Placement Review Board volunteer may apply for nomination as an Executive Board member providing they have currently been on a CPR board for at least one year.
